B E T W E E N

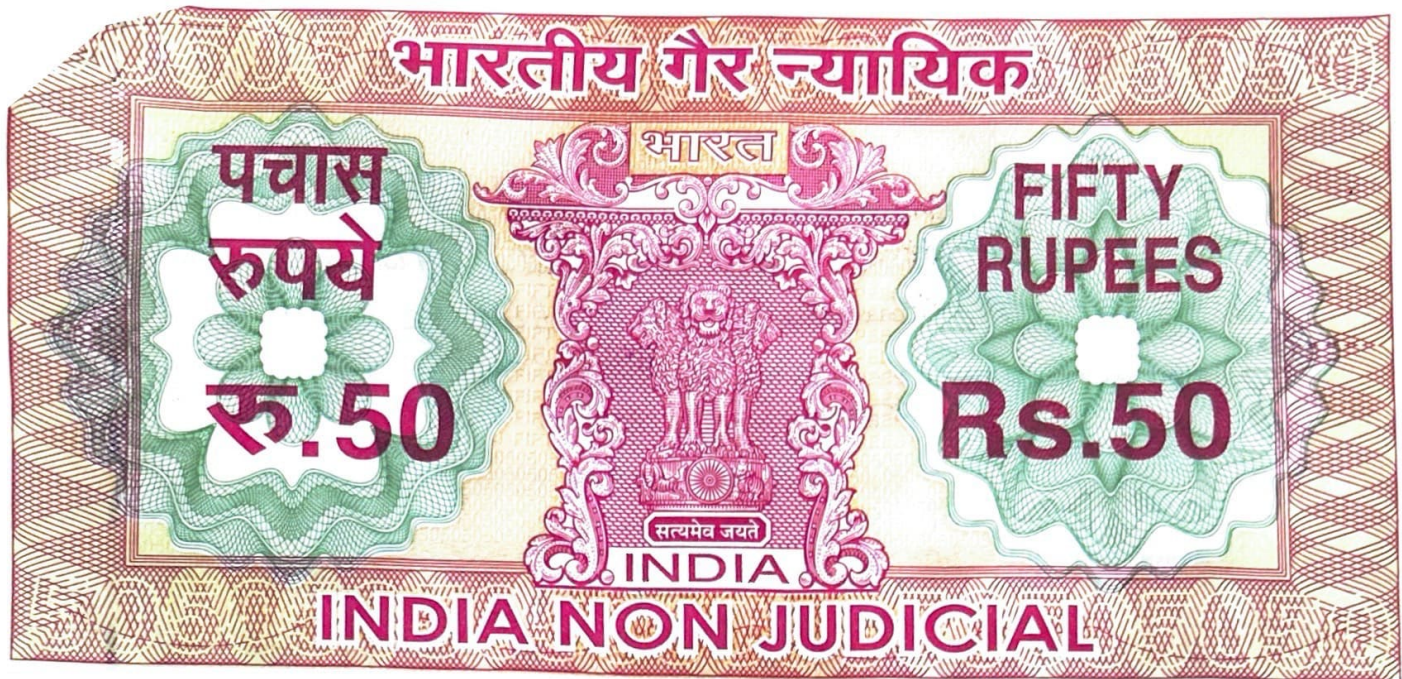

And for that purpose the Settler hereby contributes Rs. 10,000/- into the Trust Fund. The settler will also arrange suitable funds and other assets etc. from time to time for short term and long term uses, for the purposes of the objects as may be deemed necessary.

And whereas the Trustees have agreed to carry out the Trust herein created.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. The objects of the Trust are charitable and not for purposes of the profit as follows: -

a. To open, run and manage a school/ college for the education of boys and girls in the field of arts, science, commerce etc. and other vocational pursuits.

b. To establish recognized Aurvedic/ technical/ medical/ dental/ law colleges etc. for the benefit of the students in particular and society in general.

c. To establish recognized institutions to impart degree and diploma courses in any field of educational and vocational pursuits including Nursing and Paramedical courses.

d. To establish, run and manage super specialty hospitals and Medical Centres and other allied activities solely for philanthropic purposes and not for the purposes of profit.

e. To promote and carry out research activities in the fields directly and indirectly related with the objects of this Trust.

f. To give donations to other charitable Trusts and Institutions which are running for the purposes similar to this Trust or other charitable purposes.

g. To provide assistance to the poor and needy/ weaker section of the society for promotion of education by way of scholarships, grants, loans, books, uniforms etc.

h. To provide services in the field of medical services to the general public

i. To do any activity which is directly or indirectly related to or incidental to any of the objects of the trust as above mentioned.

2. Declaration of the Trust-

The settler as absolute owner has delivered cash amounting to Rs. 11,000 and will also arrange from time to time suitable funds and other assets for the purpose of the Trust on long term and short term basis to the trustees to hold the same unto and to the use of the Trustees upon trust and with, under the subject to the powers and provisions herein contained.

3. The name of the Trust shall be **'KUSHAL EDUCATIONAL FOUNDATION'**

4. Powers and duties of the Trustees-

a. The Trustees will do all the needful to establish and create the infrastructure of the institutions and other set-ups as above mentioned under the trust.

b. The Trustees have a power to form a management committee with office bearers such as Chairman, Vice chairman, Director, Treasurer, manager etc. for the purpose of the day to day management of the activities of the Trust and to fix their scope of work as to fulfill the objects of the Trust. Trustees can be the members of this committee. They can also take members from outside, if they so deem fit.

c. The Trustees shall employ such staff as they think necessary for giving the necessary human resource infrastructure and set up in the field of education and services to fulfill the objects of the trust and replace them whenever they deem it necessary.

d. Out of the receipts of the trust Fund which will also include aids, grants, donations etc. received by the Trust, the Trustees shall defray the expenses for the running and managing of the institutions and other set ups as aforesaid and capital expenditure for erecting building and creating other infrastructure for the purpose of the objects of the trust, but if the receipts are insufficient for that purpose the Trustees may use such portion of the corpus of the Trust Fund as may be necessary.

e. The Trustees shall have the power to borrow money from any bank, institution, individual or concern or otherwise on the security of the Trust property and to mortgage/ hypothecate the Trust property for this purpose.

f. The Trustees may invest the surplus funds in their hands in various movable and immovable properties and securities as they deem fit for the objects of the Trust.

g. The Trustees have the power to create new trust / society under the management and control of the existing Trust for the purposes of the existing Trust.

5. Meetings of the Trustees:

a. The Managing Trustee shall preside over all the meetings of the trustees and in his absence the Joint Managing Trustee shall preside such meeting and in the absence of both, the trustees attended such meeting may elect any one of them to preside over the meeting;

b. The meetings of the Trustees may be convened by the Managing Trustee or under his direction by any other Trustees

c. The quorum of the meeting of the Trustees shall be monthly in personal presence.

d. In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).

6. The Settler shall also be one of the Trustees during his life time and after his demise, his spouse shall become a trustee. However, if spouse does not exist on this date then the eldest male member of his family shall be a trustee, if however, there is no such male member exist on that day then the eldest female member shall become the trustee.

7. The Settler will be the permanent chairman of the Trust meetings. After the demise of the settler, the remaining trustees have a right to appoint a new chairman amongst themselves with at least 51% vote in favour of the proposed person.

The Trustee shall have power to borrow money from banks, institutions, individuals, or otherwise on the security of the Trust property and to mortgage the Trust property for the purpose.

The Trustee shall have the right to acquire lands in their hands in any manner and to sell, lease, mortgage, or otherwise dispose of the same for the objects of the Trust.

The Trustee shall have the power to execute any trust or to carry out the objects of the Trust for the purposes of the Trust and to do all such acts and things as may be necessary for the carrying out of the objects of the Trust.

Meetings of Trustees

8. In case of demise of any of the Trustees, the spouse of such person will become the trustee. However, if spouse does not exist on this date then the Eldest male member of his/ her family shall be a trustee, if however, there is no such male member exist on that day then the eldest female member shall become the trustee.

9. New Trustees can be inducted in the team of existing trustees by the Settler as she deems necessary. However after the demise of the settler, the trustees have a right to induct a new trustee with a minimum of 51% vote in favour of the new incumbent.

10. Application of the Income and Trust Fund:
The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section 13(I) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

11. Power to alter Rules and Regulations
The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. Any amendment to the Trust Deed will be carried out only with the approval of the Commissioner of Income Tax.

12. Accounts and Audit:

a. The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.

b. The year of account shall be the financial year commencing from 1st April and ending 31st March.

c. The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.

Nana K. Gyamfi

19. This is a Non Government organization and a public charitable Trust. The properties of the Trust shall in no case revert to the settler/ trustees or their descendants or to any other person.

20. The trustees are permitted to open and maintain in the name of the Trust a savings/ current a/c with any schedule bank, which shall be operated by the settler or as per his direction to the bank.

21. That the Trustees shall have the power to refer any dispute to arbitration, and to file suits on behalf of the Trust, and to compromise or compound all actions, suits and other proceedings and all differences and disputes touching the trust properties, and to adjust and settle all accounts relating to the Trust and/ or its properties.

22. That the Trustees shall maintain proper books of accounts for the Trust and shall draw its Final Accounts on 31st march each year and will also get them audited by a qualified Chartered accountant.

23. That the Trustees may reimburse to themselves and pay and discharge out of the Trust fund all expenses incurred in or incidental to the execution of the objects and purposes of the trust. If they act in any additional capacity in the day to day affairs of the activities of the institutions and other set ups of the Trust, they may be paid reasonable remuneration for their additional services.

24. Every Trustee will be at liberty to resign on giving one month's notice to the Trustees committee of his intention to do so.

25. A trustee shall vacate his office if :

- i. He/ she resigns his office as a trustee
- ii. He/ she fails without obtaining leave of absence to attend all the meetings of the trustees held for six consecutive months or three consecutive meetings, whichever occurs earlier
- iii. He is found of guilty of fraud or an act involving moral turpitude.

26. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of Trustees for operations of the Trust. In the absence of such regulations:

- a. Two Trustees shall form a quorum for a meeting of the Trustees.
- b. The meeting of the Trustees shall take place at least once in every calendar quarter.
- c. Any revision, alteration and addition to the existing rules may be done in a meeting of the Trustees by passing it with a special majority.

27. No part of the Trust fund, either the corpus or the income there from, shall be utilized for any object other than that of the trust hereby created.

28. Any revision, alteration, amendment in the clauses of this Trust Deed may be done in the meeting of the Trustees by passing it with a special majority.

29. At the time of registration of this Trust Deed, there is no immovable property in the corpus of the Trust.

30. The regd. office of the Trust shall situate at 16, Ganesh Chandra Avenue, Gandhi House, 4th Floor, Kolkata - 13 and branch office at Deshbandhu Road, Purulia - 723101, West Bengal unless otherwise so determined by the Trustees in their meeting.

31. For the purpose of the assessing the stamp duty the value of the Trust property is Rs. 10,000/- as contributed by the founder in cash.

32. Indemnity:

Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by own negligence and also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

33. In the event of dissolution or winding up of the Trust, the funds and assets of the Trust shall not be paid or distributed among its Trustees but shall be given to such other charitable Trust as may be determined by the Trustees or shall be handled as per court order, if there is any .
